

"SUPER JUNIOR WORLD TOUR "SUPER SHOW 7" in HONG KONG" (the "Concert") BEA Credit Card Priority Booking Terms and Conditions:

- 1. The priority booking service (the "Service") only applies to cardholders of a BEA Credit Card. The UnionPay Dual Currency PLATINUM Credit Card and JCB PLATINUM Card are excluded.
- 2. A limit of 8 tickets per hotline/online order applies. HK Ticketing will charge a HK\$25 customer service fee per ticket.
- 3. Tickets are available on a first-come, first-served basis while stocks last.
- 4. Each ticket admits one only, with an age limitation of 12 or above with height above 140cm for standing tickets and 3 or above for seated tickets.
- 5. Tickets purchased via the hotline/online can either be collected in person by presenting the BEA Credit Card used for the ticket purchase at any HK Ticketing retail outlet (including The Hong Kong Convention and Exhibition Centre, The Hong Kong Academy for Performing Arts, HKAPA Bethanie Landmark Heritage Campus, AsiaWorld-Expo, Kowloonbay International Trade & Exhibition Centre, D · PARK, K11 Select, and all Tom Lee Music Stores in Hong Kong. The opening hours of respective outlets are different.) or delivered by courier. The courier fees are (per transaction): Hong Kong Local Courier Post HK\$25/Macau Registered Mail HK\$30/China Courier HK\$200/International Courier HK\$250. The courier fees are charged by HK Ticketing.
- 6. Cardholders should contact HK Ticketing by calling 31 288 288 (daily from 10am to 8pm) by 19th January, 2018 if the tickets are not received, otherwise HK Ticketing will not be responsible for non-receipt of tickets. <u>Lost standing tickets</u> will not be re-issued.
- 7. All charges, including the total amount for the tickets purchased, HK Ticketing customer service fee, and courier fee (if applicable) (the "Fees"), will be charged to the cardholder's account instantly after tickets have been ordered. If the Fees cannot be debited successfully, the booking will be cancelled automatically and HK Ticketing will give appropriate notice.
- 8. Tickets cannot be cancelled, refunded, or altered once purchased.
- 9. Ticket booking, delivery, and re-issuance are subject to the terms and conditions of HK Ticketing.
- 10. The Concert is organised by Media Asia Entertainment Limited and East Asia Entertainment Limited (the "Organisers"), while the Service is provided by HK Ticketing. The Bank of East Asia, Limited ("BEA") makes no representation or guarantee as to the quality and availability of the Service provided by HK Ticketing and the Concert organised by the Organisers, or the information provided by HK Ticketing and the Organisers. BEA shall not be liable for any matters arising from or in connection with the Service, the Concert, or the information provided by HK Ticketing and the Organisers. Any enquiry or complaint regarding the Service, the Concert, or any relevant information should be directed to HK Ticketing or the Organisers.
- 11. The show date of the Concert shall be determined by the Organisers at their absolute discretion. The Organisers reserve the final right to vary or extend the show date or cancel the Concert at any time without prior notice. In the event of any dispute, the decision of the Organisers shall be final and conclusive.
- 12. In the event of cancellation/postponement of the Concert, the Organisers reserve the right to refund amounts paid for tickets or reschedule the Concert.
- 13. BEA and the Organisers will not be responsible for damaged, lost, or stolen tickets purchased through the Service and will not re-issue tickets. HK Ticketing will be responsible for the re-issuance of seated tickets.
